Attorney William Favreau reports:

- Discussed the partial abandonment of Pleasant Valley Road. Notices being sent out to residents on September 15, 2015. Informed the Town Board that a Public Hearing will be held on October 14, 2015 at 5 PM at the Chazy Town Hall. A. Rascoe, Highway Superintendent for Clinton County will conduct the Public Hearing.
- Noted that a Local Law has been drafted concerning exceeding the tax cap for 2016. He said that this Local Law is necessary if the town were to exceed the cap.

- Commented on how good the paving looks at the Town Hall.
- Asked Supervisor Henry if he had any news about the possibility of a Dollar General Store. Supervisor Henry said he has not received or heard anything.
- Asked what the status is of Gray Gables. Supervisor Henry said various letters were sent out to the owner, however, to date, nothing has transpired.
- Asked what is being done about the air in the Town Water supply. Supervisor Henry noted that various issues have been looked into, along with discussion with several water providers, however, at this point a definitive source to the air issue has not been found. Supervisor Henry noted that to hire a firm to provide answers could be extremely expensive.

TOWN SUPERVISOR ITEMS

Town Supervisor Mark Henry reports:

 Noted that work has been completed on replacing and insulating the Duprey Bridge water line, and by using the raft built by town employees it provided additional savings to the Town.

- Informed the Town Board that Tom Burdo is in his second week of school at Morrisville (SUNY) for Water Treatment. Supervisor Henry also noted that Tom Burdo and John Patnode worked this past Saturday at the lift station.
- Noted that we are preparing for winter, including the shutting off water at the Recreation Park in the near future.
- Noted that there is still work to be done at the Duprey Bridge which will include a
 water tap, corporation stop and curb stop which will provide additional insulation
 on the first few feet of the underground water main on the East side of the
 Duprey Road bridge.
- Discussed a resolution concerning Riverside Cemetery. He noted that Tim Lamica, Highway Superintendent has agreed to replace some fencing at the cemetery.
- Noted that everyone is working on the 2016 Town Budget.
- Discussed the possibility of new software for the Town's Accounting and Payroll functions. Supervisor Henry noted that RFP's have been sent to five possible vendors and hopefully we will have replies in the near future.
- Informed the Town Board that the paving of the parking lot at the Chazy Town Hall has been completed with the exception of painting/lining of parking spots.
- Noted that there is going to be a Public Hearing on October 14, 2015 at the Chazy Town Hall regarding the abandonment of the Pleasant Valley Road.
- Discussed a bill of \$1377.00 that Linda Martin received for repairs to her sewer line, noting that sewer had backed-up at her residence. Ms. Martin is asking the Town to pay for this bill. Discussion by the Town Board followed. It was the consensus of the majority of the board that we would not pay for this bill.
- Discussed the purchase/installation of a new gas furnace for the Chazy Town Hall.
- Informed the Town Board that the new phone system for the Town Office has been installed with payment for part of this paid by Unified Court Grant monies.
- Discussed a DEC Violation Report he had received, specifically phosphorus levels at the Sewer Plant. He noted that our last two tests have been well below the allowable mandated level.
